42nd Annual Benefit Dinner Wednesday September 16th

As we prepare for our annual benefit dinner this year we are reminded of the mission of the Sacred Heart Foundation. To spread the word of God by raising funds which provide financial assistance for the education of those studying to be priests and brothers of the Missionaries of the Sacred Heart anywhere in the world.

With MSC scholarship recipients located throughout the world and fewer and fewer of them originating in the United States, it is not often that we are given the opportunity to spend personal time with an actual MSC scholarship recipient. Fortunately, a visit with Mr. Daniel De Vito who is spending two months here in Cape Vincent and Watertown this

summer, provided a closer look at a twenty-three- year- old young man with aspirations to join the community of the MSC through its formation program. Mr. De Vito was kind enough to spend time sharing a little about his life and his calling to the priesthood.

Mr. De Vito has spent the greater part of his life in Pennsylvania and was an active participant in his local parish community during his younger years. He says he was engaged in a variety of activities and always felt very at home with the church. While attending Gannon University in Erie, Pennsylvania, he was involved with various service and social justice initiatives. He had the opportunity to work in educating others about social injustices and the social teachings of the Catholic Church. It was during this time that Mr. De Vito was drawn to the work of the Benedictine Sisters of Erie. He admired their charism, the way in which people respond to God's call. The Benedictines seek God in the communal life and respond in prayer and ministry. He admired the work of these sisters and realized that he, too, could serve God in a similar fashion as a priest or brother. He began to contact religious communities and saw how each community lived their charism differently. Although each community contributes to the life of the church in a unique way, it was the charism of the Missionaries of the Sacred Heart that resonated most

with Daniel. After graduating from Gannon University with a degree in Philosophy, he decided to apply for entrance into the MSC aspirancy program.

Mr. De Vito currently studies at Catholic Theological Union in Chicago where he is working towards his Master of Divinity degree along with a Masters in Theology with a concentration in intercultural studies. He says that he has always been interested in theology and also in the changes in the church after the Second Vatican Council. He is currently the liaison between CTU's social justice group and the neighboring seminaries to build ecumenical relationships. He believes that ministry should be deeply tied to the community of faith, and seeing how the Missionaries of the Sacred Heart collaborate with the laity, has strengthened his desire to continue with formation. Mr. De Vito sees Jesus as ministering within the context of a community and he hopes to follow this example as a disciple.
